#### I. Call to Order

Chairman Dean Newell called the meeting to order at approximately 11:00 a.m. ET. Attendees who were not identified through their Zoom video were asked to introduce themselves. A video by DriverFacts, the sponsor of the 2021 TCA Spring Business Meetings, welcomed participants to the meeting. A motion was made, seconded, and passed to conduct the meeting according to the antitrust guidelines. A motion was made, seconded, and passed to approve the minutes of the previous virtual meeting on September 22, 2020.

# II. FMCSA Update – Joe DeLorenzo, Acting Associate Administrator for Enforcement, FMCSA

Joe DeLorenzo of the Federal Motor Carrier Safety Administration (FMCSA) updated attendees on the various actions taken by FMCSA in response to the coronavirus pandemic through waivers granting additional flexibility for the industry. He discussed the new hours-of-service (HOS) regulations, which went into effect in September 2020, and corresponding ELD compliance figures. He also noted the impact of the Drug and Alcohol Clearinghouse and answered questions from the group.

# III. Discussion of TCA Limiting Speeds on Trucks Policy – David Heller, Vice President of Government Affairs, TCA

TCA's David Heller introduced new proposed policy language for the association regarding Limiting Speeds on Trucks. The language mirrored the policy language recently adopted by the American Trucking Associations, and consideration of this language was recommended by the Advocacy Advisory Committee. A motion was made, seconded, and passed to present the proposed updated Limiting Speeds on Trucks policy before the Board of Directors for their approval.

# IV. Overview of Regulatory Comments Submitted – Kathryn Pobre, Manager of Government Affairs, TCA

Kathryn Pobre explained to committee members that TCA had filed seven regulatory comments since the last committee meeting in September. These comments included five to FMCSA regarding the proposed 3-hour pause pilot program, the 18-20-year-old driver pilot program, the definition of yard moves, recordkeeping requirements, and rear impact guards. Additionally, comments were filed with the Department of Labor in support of new rules for determining independent contractor status and with the Department of Health and Human Services in opposition to the proposed hair testing guidelines.

Since there was no old or new business to address, Chairman Newell called for a motion to adjourn and the meeting was ended at approximately 11:50 a.m. ET.
